PRSD finished the 2021 – 2022 school year with full in-person instruction. Masking was optional. The district did not conduct contact tracing or make quarantine notifications. The same approach used to finish the 2021 – 2022 school year will be implemented for the 2022 – 2023 school year. The same approach will continue for the 2023-2024 school year.

The full continuum of services is available for all PRSD students, families and staff. Extra-curricular and co-curricular activities are available to all students.
